THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY, OREGON (the Board) sat for the transaction of county business on September 22, 2022, Commissioners Lindsay Berschauer, Casey Kulla, and Mary Starrett being present.

THE BOARD MAKES THE FOLLOWING FINDINGS:

A. WHEREAS, Yamhill County has acquired title to certain units of land, and any improvements that may be thereon, as described in Exhibit A (attached hereto and incorporated herein), which are not being used for County purposes; and

B. WHEREAS, it is deemed to be in the best interests of Yamhill County to sell the properties at a public sale pursuant to the provisions of ORS 275.110 – 275.250; and

C. WHEREAS, such properties have market values as determined by the tax roll at the last equalized value on the assessment roll for the property as set forth in Exhibit A; and

D. WHEREAS, the minimum bid prices for each respective property shall be as set forth in Exhibit A; and now, therefore

IT IS HEREBY ORDERED BY THE BOARD AS FOLLOWS:

1. That all of the right, title, and interest of Yamhill County in and to the real property described in Exhibit A be sold at public auction in the manner provided by law, by the Sheriff of Yamhill County, to the highest and best bidder subject to the following conditions:

A. The sale price shall be paid in cash and not less than the minimum price stated in Exhibit A; and

B. All such sales shall be final; and

C. The County shall not warrant or defend the fee simple title of real property offered for sale to be free of defects or encumbrances, but will only convey such title as the County has acquired by foreclosure; and

D. Purchasers must also pay the cost of deed recording; and

E. Conveyances shall be subject to any easements of record.

2. That the Notice of Sale, attached hereto as Exhibit B, shall be published in the News-Register, a newspaper of general circulation in McMinnville, Yamhill County, Oregon, at least once each week for at least four consecutive weeks prior to the sale.
3. That notice shall also be published on the Yamhill County website.
4. That the sale shall be conducted on November 1, 2022, at 10:00 A.M., in the Yamhill County Courthouse, 535 NE 5th Street, McMinnville, Oregon.
5. That the Sheriff's Return of Sale, as required under ORS 275.160, shall be recorded, along with a copy of each Certificate of Sale and the proof of advertisement, after the public auction has concluded.

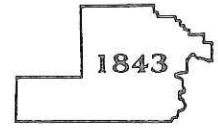
